

WAPOR 2025 Highlights (1)

Membership. WAPOR's global network now includes over 500 members and friends across 102 countries. This includes 27 organizational members. This diverse and dynamic membership reflects the organization's unique international character and relevance across academic and professional communities.

National Representatives. WAPOR's network of 102 national representatives continues to serve as a vital channel for engagement and visibility worldwide. Representation spans all global regions and economic tiers, reinforcing WAPOR's mission to promote high-quality public opinion research globally.

Regional Chapters. WAPOR's regional chapters remain highly active in 2025. The Latin America and Asia Pacific chapters each host their own regional conferences this year, drawing strong participation and regional focus. The MENA and Sub-Saharan Africa chapters contribute through targeted webinars and professional outreach, extending WAPOR's presence and programming beyond the annual conference.

WAPOR 2025 Highlights (2)

Annual Conference. WAPOR's 2025 Annual Conference was held in St. Louis from May 12–15, bringing together 151 participants from 38 countries, including 19 students. The program featured 26 WAPOR-organized sessions and 3 joint panels with AAPOR, along with a joint networking reception that encouraged cross-community exchange.

Monthly Webinars. As part of its ongoing commitment to global dialogue and professional development, WAPOR organized seven webinars in 2025. Topics included sampling challenges, AI in public opinion research, transparency, political polling, and youth engagement—featuring diverse voices from across regions.

Annual Report Released. The 2024 WAPOR Annual Report was published in early 2025, providing members with a comprehensive overview of the organization's achievements, financial position, and strategic priorities. The report reinforces WAPOR's commitment to transparency and accountability.

80th Anniversary Strategic Goals [1947-2027]

- **1. Strengthen Global Representation:** Expand outreach and support to underrepresented regions and researchers, particularly in Tier B, C and D countries, to ensure WAPOR reflects the true diversity of the global public opinion research community.
- **2. Advance Transparency and Data Integrity:** Promote adoption of rigorous transparency standards across all WAPOR activities, including journals, conferences, and institutional practices, building on current initiatives like the Transparency Policy and the Transparency Alliance.
- **3. Deepen Impact Through Partnerships:** Enhance strategic collaboration with sister organizations such as AAPOR, ESOMAR, ISSP, and regional associations to foster methodological innovation, joint programming, and advocacy for high-quality survey research.
- **4. Invest in the Next Generation:** Develop stronger pipelines for student and early-career researcher engagement through mentoring, scholarships, training, and leadership opportunities within WAPOR.
- **5. Modernize Communication and Member Services:** Upgrade digital platforms, streamline member services, and amplify WAPOR's visibility through open access content, multilingual outreach, and real-time engagement with global issues in public opinion.

Future Plans in 2025

Global Network. WAPOR will expand its **network of national representatives** from 102 countries in 2025 to 130 countries by 2027 and **increase support for regional chapters**. To promote equitable access and visibility, the annual conference will rotate across world regions to ensure broader participation.

Consultative Bodies. WAPOR will establish a Strategic Advisory Board of Former Presidents to guide long-term priorities, ensure continuity, and advise on emerging challenges. A Global Industry Advisory Group will also be launched to strengthen ties with the commercial research sector, encourage dialogue between practitioners and academics, and broaden WAPOR's applied relevance.

WAPOR Working Groups. Member-led Working Groups will be created on key thematic and methodological topics, based on open consultation. These groups will foster ongoing exchange, resource development, and cross-border collaboration, with possible outcomes such as webinars, joint publications, and conference panels. Working Groups will be supported administratively but guided by member interest and leadership.

Annual Membership Consultation. WAPOR will hold an annual virtual consultation to gather input from members worldwide. This structured feedback process will inform Council decisions and help shape future activities and services.

Constitution Review 2025

- December 17, 2024 Task Force on Constitutional Review set up, membership comprises Robert Chung and Timothy Johnson.
- March 11, 2025 Task Force proposed to the Council that by-elections should be introduced for the posts of President, Vice President, and Secretary-Treasurer in case a vacancy arises more than six months before the term of service ends.
- May 12, 2025 Council (in St Louis) decided to hold the four-week membership referendum in parallel with the annual election of 2025.
- The Task Force will draft the word-by-word amendments in due course.

Abstract



77th Annual Conference in Seoul, Republic of Korea, July 28-31, 2024

A total of 408 participants from 51 countries attended the 77th WAPOR conference in Seoul, Republic of Korea. WAPOR extends its heartfelt gratitude to Sungkyunkwan three impressive keynote events. The opening keynote-or liberty-was given by Kathleen Frankovic (Independent Consultant, USA) who addressed the importance of polling and ways to protect the freedom to poll. The second key note addressed the aspect of quality in survey research: Tom W. Smith (NORC at the University of Chicago, USA) spoke about the need to maintain data quality amid measurement disruptions. The closing keynote was an engaging roundtable discussion on the role humanity plays in the survey profes sion, moderated by WAPOR President (2023-2024) Robert Chung (Hong Kong Public Opinion Research Institute Hong Kong). Speakers included Eun-Ju Lee (Seoul National University, Republic of Korea), Colin Irwin (University of Liverpool, UK), Christof Wolf (GESIS-Leibniz Institute of Social Sciences, Germany), and Lai Sim Fong Zoe (On&On Theater Workshop, Hong Kong; presenting for Daniel Wetzel Rimini Protokoll, Germany), thus bringing academic, prac



Increase Membership Numbers

- We proposed in 2024 to make it possible to apply and obtain 2 and 3 year membership. Following the WAPOR Council decision, the changes will be implemented in October 2025
- Reduce attrition among existing members. We designed and implemented a survey among non renewing members of WAPOR. It is currently in field, and will give us information on how to reduce attrition among WAPOR members



Promote the addititional tiers of the membership

- Organizational membership has grown from 10 in 2024 to 27 in 2025, we plan to increase it further
- The Friends tier of membership has grown to 60 in 2025, we plan to continue promoting it as the first step to becoming a full WAPOR member
- The tier with the biggest potential for growth is Friends. Several potential routes for the membership growth in Friends tier:

2025 Conference Program

- The 2025 WAPOR Annual Conference takes place in St. Louis, Missouri, from May 12 to 15. The program featured 26 WAPOR-organized concurrent sessions over four days. In addition, three joint sessions were developed in cooperation with AAPOR and scheduled to encourage cross-participation.
- Sessions addressed a wide spectrum of public opinion research topics, including media trust, political polarization, youth political engagement, cross-national methodology, AI and data governance, and electoral behavior. Presentations reflected both academic and applied work from across global contexts.

Conference Participants

The 2025 WAPOR Annual Conference brought together 151 registered participants, including 19 students. Attendees represented 38 countries, highlighting the international scope of the event.

The largest group of participants came from the United States, followed by Germany, the United Kingdom, Canada, and the Netherlands. The conference also saw engagement from researchers based in Latin America, Asia, Eastern Europe, Africa, and the Middle East.

New member participation was notable, with 37 percent of registrants joining WAPOR during the registration process.
